

Report from Pat Elrington

In the July (1979) Edition of Midlands Judo it stated in the 'Club Visit' column that we visited Holland to compete against Continental Clubs.

Someone over there must get the 'mag' because we soon afterwards received an invitation to compete in a Judo Jubilee in Holland with teams of six Men and six Women. We arrived in Holland at 6-00am to be taken to our accommodation by our Host and then went on to the Sports Hall and met the other Teams from Denmark, Germany, France and Belgium and of course the Dutch Team. The Event started to time with the Bushido Men's Team first on against a German Team to win 5-1 and then went on to beat the Dutch Team until meeting the French Team who were the favourites to win with a fourth dan, two third dans and three first Dans in their Team. With three wins each the Bushido scraped into the quarter finals with a superior points score where we beat the Danes convincingly but by some strange arrangement met the French again in the semi-final? With the debate as to how we could meet again continuing, the Teams fought another draw of three wins each but this time the French going through by two points. The French then won the final by six ippons!

INTER-COUNTY CHAMPIONSHIPS . . . **ELIMINATIONS**

The Inter-County Championships will be for one Team of Boys and One Team of Girls in the Ten weight categories used for Area/ National Events during 1979 which will be arrived at by County eliminations held in each County Area at the venues shown against the County organizer's name. In most cases all the eliminations will be fought on the 1st of March though some, like Birmingham will be on the Sunday 2nd March.

These eliminations will take the form of individual knockout and repechage contests to determine the best player in each weight category for each County Team. The second placed player will be the reserve.

An entry fee of £1 will be required for each elimination event to pay for the venue etc. and assist in buying badges and paying transport etc. for each County team so selected. Spectators will be charged admission of 50p. Unless each Area organizer so decides, medals are not required though each Event carries with it the title of 'County Champion'.

All contests in the eliminations will be of three minutes, and fought under BJA/IJF rules.

The counties are as follows. Hereford and Worcester (1), Warwickshire (2), Staffordshire (3), Nottinghamshire (4), Derbyshire (5), West Midlands Metro (6), Leicestershire (7), Northamptonshire (8), Lincolnshire (9), Shropshire (10), Birmingham (11), Buckinghamshire (12). Birmingham is being treated as a County because of the large number of Clubs within the boundary which now includes Sutton Coldfield.

The entry form opposite must be completed as per a normal Championship and sent to the County Organizer for your particular residential Area. He will return your Competitors card with details of Venue and times etc. It is essential that entries are submitted by the closing date of 21st February. Late entries will not be considered. The County Championships will be fought at Haden Hill on 14th June, 1980. Do not enter the eliminations unless you are available on this date. 

Comment by AMA

Like me, you were probably curious about the paragraph in the 'Questions Answered' column in the British Judo Association Newsletter published on December 20th, 1979, which reised the query, "I have read the booklet produced by the Midland Area that armlocks and strangles may not be offered for examination by candidates under the age of 12 and this means that juniors under that age may not be graded above 10th Mon. The 'Official' Junior Promotion Syllabus does not confirm this. What is the situation?

Answer... The Junior candidate of any age between 8 and 15 years inclusive can select any item from the junior syllabus.

Now isn't that strange! Why would the Midland Area co-operate in producing a book at a cost in excess of £2,000 when the information contained therein is incorrect? Well of course they haven't, but the BJA Newsletter says that their interpretation is the correct one. So, let us look at the problem in detail.

The BJA Training Sub-Committee produced the basis of a Junior Syllabus in the summer of 1978 and by 11th October 1978 issued a comprehensive study called 'The introduction of a 'Theory' section into the Promotion requirements for Mon Grades'. FINAL DRAFT. This was based on two earlier reports which were prepared through 1977 and 1978 the first being distributed in February 1978.

This Final study ran to 15 pages in all and was comprehensive in that it detailed the composition of the Theory syllabus, its workings and instructions to the Examiner and the Candidate and even the proofs of the Syllabus card now printed and issued.

The Management Committee approved this report in its entirety without any deletions, amendments or additions early in 1979 and authorised the introduction of the Junior Syllabus.

So what happened next? Well, not a lot, at least not until the Yorkshire and Humberside Newsletter published a photostat of the Syllabus in their September edition which showed just the instructions to Examiners and Candidates part of the Syllabus and a list of the techniques etc. This was then repeated in the October circulation of *British Judo* saying that the syllabus was introduced from the 1st Septemberl in *Judo North West* of October, Peter Holme wrote that the North West Area had not been informed of the Syllabus and their Senior Examiner knew nothing about it. Well, Officially, neither did anyone else.

Peter also makes a statement that might be pertinent in this case, "An Association starts to lose its democracy when it fails to communicate or consult its Members, but perhaps it's rather deeper than that . . . perhaps someone forgot to tell the Management Committee."

Now it is possible I suppose that someone has forgot to tell either the Management Committee or the Members that they have altered the Junior Syllabus, no doubt they have also forgot to tell the Training Sub-Committee who spent a year of research designing it. Tony Reay says his interpretation is 'Official' and he got it from the 'Horses Mouth', but nowhere in the Training Sub-Committee Minutes or the Management Committee minutes since the original approval is there any amendment authorised.

Perhaps Peter Holme is right, perhaps democracy has failed.....or perhaps someone just forgot!

A clue to what might have happened lies in the following minute of the Training Sub-Committee for 22nd January 1979 . . .

Item 7, "It appears that HQ have lost the final draft (of the Junior Syllabus) that the TSC had sent several weeks ago.....

The Meeting expressed displeasure in the way HQ had handled this item!"

No doubt when Head Office find their copy of the 'Final Draft' they will look up what has been missed out and inform Members accordingly or, seek the amendment they obviously desire from the Management Committee, perhaps before they do so, it would be prudent to check with the Director of Examiners in each Area first. From most of the Examiners with whom we have had contact there is the feeling that this time the Training Sub-Committee got it right and whilst not restricting the practise and knowledge of armlocks and strangles (it does in fact encourage Juniors to know them all by the time they are twelve), it does help standardize grades and makes the chances of overgrading more remote.

GOHN BEARD TALKING SHOP

I have written previously my opinions regarding the attitude of the Russians to Britain and sporting relationships with South Africa.

I have just returned from my first visit to South Africa. Coincidentally I invaded South Africa almost at the same time as Russia invaded Afghanistan. JUDO IS

Something the British

Press have never heard

about.

As you will have seen in last month's Midlands Judo the World Championships in Paris provided a spectacle I, and 6,000 other spectators will remember for many years to come.

Everything about the Tournament I found to be superb except for just one aspect. The organization was faultless, the Judo was fabulous, the French spectators were marvellous, full of appreciation and delighted by the magical performances of the Fighters, and the atmosphere was electric.

There was just one blemish, which did not spoil the tournament—nothing could have done that—I was confused by the Refereeing. Naturally each Referee was qualified by the IJF and for the first half of the four-day Event I was totally bemused by much of the Refereeing, but then I got used it. It was not the mistakes or any unfairness that I found bemusing, it was the interpre-

tation of the IJF Rules as exercised by the Referees that surprised and confused me.

The standard of Judo at that level is so high that grip fighting played an essential part in most contests so that in some cases no attacks were mounted for as long as two minutes into a contest, but, seldom were passivity penalties given.

Pushing out and stepping out of the contest area was practised by most fighters, especially those from Japan, but on no occasion was a Keikoku awarded.

When, in the few cases where a penalty was given, it was always a Chui. Head diving from forward throws was common practise but no player was disqualified for such an act. Only one Chui was awarded to a fighter stepping out whilst attempting an attack, although such acts were commonplace.

The reaction of the audience, which was very educated Judo-wise, to referees who failed to give scores or Osaekomi or notice Toketa was immediate and loud. Most of the spectators, however, except for the British, seemed generally satisfied with the standard of refereeing, and very few fighters registered any signs of complaint. It is also true to say that except in one case the contests were won by the right man.

There was far more leniency excerised by these Referees than I have ever seen from British referees and it would be interesting to hear from some of the BJA Officials in Paris as to what they think of their foreign colleague's performances.

Editor . . . In the 1975 World Championships, in my report for the Area newsletter I wrote: ". . only three Keikokus were awarded in the whole of the Championships, only two of which were for stepping out offences. The continuity was better and it was always the attacker that won, not the man who secured a penalty and hung on to it." It seems that nothing has changed. We are still out of step with Referees rather than players deciding results.


JUDO PHOTOGRAPHY

Last month I showed how to up-rate film speed so as to maintain high shutter speeds, selective aperture settings and avoid the harsh shadows caused by direct flash. Already this has brought some response in that I have had a couple of queries about up-rating colour films. Colour negative films, that is those that produce negative images on the film and positive colour prints, should not be up-rated. Slide film (Ektachrome) may be 'pushed' as much as three full 'stops' i.e. 400 ASA to 3200 ASA though it is not recommended to 'push' beyond 1600 ASA. Process paid films should not be up-rated as they are all machine processed at the manufacturers ratings.

This month I shall continue to talk about the aperture of your camera lens and its effect on the 'Depth of Field'. As mentioned last month, depth of field is the distance both in front and behind the subject which is in focus and this is controlled by two things, 1. The focal length of the lens and 2. The aperture

setting (f number). Basically depth of field is greatest with a lens of short focal length (28mm) combined with a small aperture (f 22). Depth of field in this example would be infinite. Look at the enclosed picture of a landscape taken on 400 ASA film on a frosty, misty afternoon. The camera was a small Haminex Compact with a 40mm lens set at 1/60th of a second to maintain the aperture at f 16 (lits maximum). Just about every part of the picture is in focus which shows one use of depth of field control.

In Judo I use this control when I have the audience behind the players so that the action remains in focus and the crowd reaction forms an integral part of the picture. In the case of individual portraits I would select a longer lens (80mm or 135mm) and increase the shutter speed so that I achieved a larger aperture. The photo of Nowak as used in December's magazine was taken with a 200mm lens at 250th second and an aperture of f 4. This has tended to isolate the player from the background which has just become a blur. This also helps magazine or paper designers who can crop pictures to suit the size available without losing detail and gives them areas of the photograph on which they can put titles without obscuring anything important. Practice by taking the same picture with your normal camera lens. Firstly with the fastest speed possible to combine with the largest aperture and then with a slow speed (30th sec) and a very small aperture and compare the prints. After a couple of tries, you should be able to achieve the effect you want. At the slow speeds, take care to hold the camera firmly to avoid blur from 'camera shake'. This, and other causes of error, next month. By the way the landscape was taken by 12 years old
