

In the centre pages this month is a pull-out poster for the National Team Championships which the Area are staging at Haden Hill on Saturday, 22nd March, 1980.

This, in my opinion, is the most enjoyable of all the domestic competitions and usually provides for very exciting Judo. On our 'Home Patch', Harry Hobbs and the Men's Squad are anxious to do well and we should have a strong Team with a number of the youngsters in the Team for the first time. The day starts at 10-00am with Finals around 5-30 pm.

There will also be entertainment between the semi-finals and final and most of the Olympic Squad players will be seen in action. Admission is just £1 for adults and 75p for Children with discount available on pre-contest bookings of five or more adults. PLEASE GIVE YOUR AREA AND YOUR TEAM YOUR SUPPORT. In the evening of the Event there will be a Dinner at Haden Hill with tickets limited to 250 places. cost is £6 per head and applications will be processed as received.

As you know, 'Midlands Judo' is published by the Area as a non-profit making informative magazine primarily for the benefit of Area Members but now with a much larger National interest than when conceived. The Area subsidise the production of the magazine to the tune of around £80 per month which is about what it would cost us to produce a duplicated newsletter but unfortunatley in recent months this subsidy has increased dramatically.

With a 20% increase in printing costs plus the large postal charge increases which we have now faced on two occasions it is inevitable that the cost of the magazine will rise. As a consequence from the April edition the cover price will be 45p per copy with discounts on sales remaining the same. Advertising costs will also be increased proportionately. The cash flow situation is not helped by those Clubs who take several months to pay for their copies and just recently around £500 was owed by Area clubs who are slow in payment of their invoices.

Please ensure that your Club is not one of these and help us continue producing the best Judo magazine currently available. Subscriptions will be invoiced at the new price when due for renewal. I regret that we have insufficient space for the third part of 'Judo Photography' this month which we hope to include in the April edition.

Dear Editor.

As you are obviously aware, there are moves afoot to alter the qualifying arrangements for the National Boys and Girls Championships. There are a number of suggestions being floated about and I fear that the Management Committee in their wisdom(?) will suddenly inform us all of a change about which the majority of the competitive clubs will have no prior warning and with which a lot of them will disagree.

As the BJA seems incapable of consultation, perhaps Midlands Judo could throw open its pages to all Areas, Clubs and Individuals, to obtain an informed position on grass roots feelings on ways of improving the National Junior Championships.

As a starter, I would suggest a grade limit be imposed to ensure that the competitor had some Competition experience prior to the Nationals.

You may be aware that the Weight Categories for Boys have been changed. This has happened without consultation as far as I can see. I believe the suggestion left the old Competitions Sub-Committee as a discussion document and now we find we have competitions being arranged in two different systems and no Official notification has been given to Areas or Clubs. Indeed if you ring headquarters you will probably be informed that there has been no change.

The view that I have put to Head Office on numerous occasions is that there should be a notification to all Clubs (not only Areas as some Area communications are as bad as the BJA's) of proposed changes six months before they are due to take effect. This should apply to any change be it in refereeing, weights, grading

syllabus or what have you. Perhaps there are others who would support this idea.

May I conclude by adding congratulations to you on your excellent magazine.

Dear Editor,

Not only did the BJA Newsletter of December issued by Head Office get the rules about the Junior Syllabus wrong it also stated that a Junior must hold both a Junior and a Senior Licence to enter a Junior Tournament (when already a Senior Licence holder) which is, of course, rubbish.

On 5th September 1976 the Executive Committee, of which I was then a member, approved a document entitled Classification of Players which states quite clearly that a Junior player wishing to enter Senior Events must become a Senior Member by taking out a Senior Licence. If the Member still wishes to enter Junior Tournaments he or she does not have to become a Member twice.

This bye-law is still current and has not been repealed.

How do I know? Well I have received a copy of every Management Committee Minute since that date and better still the Management Committee (via the Chief Executive) has asked me to look at the document with a view to updating it.

Why do Head Office invent rules? It's this type of thing that makes one wonder why we need Committees.



#### GOHN BEARD TALKING SHOP

Judo doesn't often make the newspapers except on occasions such as Superstars when Brian Jacks has appeared or a page three in the Sun. It's amazing how often the fabulous dolly-birds displaying their charms in various publications are listed as bleck belts. I wish I knew which Clubs they used for practise—or Judo, for that matter. If Judo really did produce such ravers perhaps it would receive a little more attention.

Let's face it, you can't really expect a nation such as ours to be interested in Gold medals in World Championships won by Neil Adams, when we have such a treasure trove of International trophies won by other Sports!! When, on the few occasions Judo does got some publicity the question 'Is Judo more popular nowadays?' is often heard, and reply given "Oh Yes." End of conversation.

Just take a few moments to consider the set-up we have in the BJA in England. There is a Head Office employing 9 people full-time and approximately 1,200 committees and sub-committees, National, Area and Club. Assume that at least 3 members serve on each Committee meeting monthly for 2 hours and you have more than 3,600 people meeting for 104,400 hours which is the equivalent of 51 people working full-time.

More than 70% of our Members are Juniors and as children do not to my knoweledge hold office, something like 40% of Senior licence holders have a Committee seat of some description, which means that one in eleven Members is an Official.

Now consider the major developments of the last 10 years. The old executive has been replaced by a Management Committee and the Association has been converted to a Limited Company. A set Junior and Senior Syllabus has been introduced. A Tournament Handbook has been brought into use and the BSJA

has been accepted into the fold. A Teacher's Award scheme has come into existence and a Junior Proficiency Award has been outlined though not put into operation. THAT HAS TAKEN THE EQUIVALENT OF 52 WORKING YEARS TO ACCOMPLISH.

A friend of mine claims that the best Committees consist of three people, when two of them are in hospital. It is inconcievable that a Sport so top-heavy with Management should have made so little progress. It is quite obvious that some of these Committee Members are taking their seats just for the sake of being on a Committee.

There are many people in Judo who work very hard, with little reward, with no other motive but to benefit the Sport. Such people are truly dedicated and without them we would have no Sport. There are however, many others who are no more than compulsive Committee sitters doing nothing other than strangling the efforts of those working for progress. Unfortunately, they tend to stay the course, largely because they do nothing and consequently there is no drain on their mental or physical stamina, whilst the genuine worker is beating his brains out to get things done.

It is so easy to be obstructive simply by not doing anything at all, furthermore, only those who are active are criticised, and the critics are those who do nothing themselves. Why do people wish to hold such positions if they have no intention of working in them?

It seems to me that we are suffering from a severe case of 'too many Chiefs and not enough Indians', and it is not surprising that the volunteer 'Indians' do from time to time give up out of sheer frustration.

What should we do? Well if we got rid of those that do nothing and replace them with the dolly-birds we might be able to relieve some of the frustration!

#### "BITS AND PIECES" **News and Comment in brief**

At a meeting of the Training Sub-Committee in February the Chief Executive produced a copy of Midlands Judo to point out the article 'The Meeting Expressed Its Displeasure', concerning the Junior Grading Syllabus.

After some discussion the TSC agreed that the syllabus may be operated without the age qualification for armlocks and strangles. No doubt Management Committee approval will now be sought but before any Official changes are made it would be as well to await the outcome of the Conference of Directors of Examiners as I understand there will be a proposal (not from the Midlands) for the age limit to be retained as originally approved.

Judo Magazine, the publication of the Company Judo Ltd, has now been sold to Judo Sponsors Ltd, and will in future be edited by Colin McIver in Scotland. It will be redesigned into A4 size and printed and distributed from Edinburgh and there is a possibility that in a year's time it will have a full-colour cover and centre spread. Judo Magazine has in recent years seen its circulation slip dramatically and has been largely sustained by the trading part of Judo Ltd, for which it provided the advertising medium,

At the meeting of the Training Sub-Committee in February it was announced that the New Coach Award Scheme Book has been printed and 1,000 copies obtained for distribution.

The unusual thing about it is that it is the same book thatr was issued in 19 .... when ever it was, so the New Coach Award Scheme that has taken so long to prepare is the Old Coach Award Scheme. So much for re-vitalization.



Strange happenings in Judo administration are not at all unusual though surely there could have been no stranger happening than the resignation of the National Competitions Sub-Committee 'en bloc' after a running confrontation with the Chairman, Charles Palmer over Championships seeding of Competitors.

After refusing to accept their undoubted expert opinions Mr Palmer seems to have persuaded the Management Committee to change the rules so that only medallists from previous years are seeded apart, with some vague promise of first round geographical separation.

When operated for the first time at the British Open for Women this rather upset the foreign competitors who found they were fighting themselves in the first pool. Fortunately a timely telephone call from the Chairman gave authority (can he do that?) for geographical separation to take place in the first round . . . but only for the foreign competitors. As a result the British players then proceeded to eliminate each other.

Even more strange is that when the National Trials for Young Men, Women and Senior Women were held on 2nd and 3rd February, the new Competitions Sub-Committee used the original seeding methods employed before Mr Palmer's edict. Perhaps he just grew tired of their faces.



Apparently, the Management Committee are upset that the Area should use the BJA badge notif on their publications and I understand we are about to receive a 'telling off' from the Chief Executive. We have already agreed at an informal meeting with the Finance Sub-Committee that in future, our productions which bear the badge will have 'Midlands' in the space underneath the figure but everyone else beware! If your stationery has a badge on it, cut it out straight away, and remember you are only shareholders of the BJA and its Members, you have no rights to display that fact.

Incidentally, we did take legal advice on using the BJA badge some years ago and were informed that as the copyright belonged to the BJA and that we were an elected Committee of the Members of the BJA then we had every right to use the badge. Unless that is, the BJA wants to sue the BJA.

It is worth considering that the Area have published something in the region of 30,000 books and magazines in the last 12 months and other Areas like the North-West with their Newsletter Judo North West have also displayed the flag to the benefit of the BJA. I would have thought they would be glad of the publicity.

We are also in trouble with the Training Sub-Committee (both Members), who at their meeting in November objected to the Syllabus Books which we have published. It seems that there are errors of technique which they want us to excuse by putting errata slips in each book. Whilst not denying that improvements could be made, there is in fact a note in the front of the Kyu Grade Syllabus book which states that it is only meant as a guide to pupils taking the Theory Examination and not intended to suggest the definitive method of executing the technique,

It is also a pity that the Training Sub-Committee did not have the initiative or commitment to invest £3,000 of their own money, in producing the books themselves. Then we wouldn't have made any mistakes.

After Championships at Haden Hill, we often find an assortment of abandoned personal posessions and after the Jack Law Event we have a child's purse with some money in it waiting to be claimed and also a

Changes in Girls' weight categories could also be on the way.


